- 1. Call the Meeting to Order and Establish a Quorum: The meeting was called to order by Jerry Clinesmith, Vice President, Llano County ESD #1, at 9:00 a.m. A quorum was established.

Year to Date Actual Revenue is \$530,177.98. Year to Date Actual Expenses is \$303,329.87 representing a surplus of \$226,848.33 for the year to date.
