- **1.** Call the Meeting to Order and Establish a Quorum: The meeting was called to order by David Johnson, President Burnet County ESD #1, at 10:00 a.m. A quorum was established.
- **2.** <u>Pledge of Allegiance</u>: The Pledge of Allegiance was recited by the Board members and all others in attendance.

Financial reports for month ending 04/30/2020 showed 2020/2021 taxes collected to date of \$421,206.38 Representing an 96.98% collection percentage. The collection for 04/30/2019 was \$397,079.58. Which is up \$24,126.80 from this time period last year. Account balances for all accounts as of 04/30/2020 is \$655,368.98 Year to Date Actual Revenue is \$453,117.04 Year to Date Actual Expenses is \$292,478.95 representing a surplus of \$160,638.09
